Important! Update Your Address with Medicaid and Healthy Kids Montana



Medicaid and Healthy Montana Kids (HMK) coverage renewal notices will be sent out starting April 1, 2023.

Everyone with Medicaid and HMK needs to keep their address updated with DPHHS.

The easiest way to update your address is to fill out the Change of Address Form or call 1-844-682-6837.

How to Apply to MLSA
